- 1. Hire two student advocates to work with and assist struggling students to focus on learning gaps (62,000).
- 2. Provide Educational Leadership development for LIA program (2,000).
- 3. Hire a student attendance advocate to work with students (40,000).
- 4. Offer 3 buyout periods for teachers to work with Edgenuity students (33,000).
- 5. Offer 3 classroom buyouts to decrease student/teacher ratios as we experience population growth (33,000)
- 6. Increase part-time counseling position to full-time to decrease student load on counselors and allow them more time to guide and work with struggling students (53,000).
- 7. Purchase a share of Edgenuity licenses for student credit recovery (4,200).
- 8. Hire a mental health specialist to work with students who struggle (30,000).
- 9. Purchase licenses for Panorama to enable teachers and counselors to have access to student information which identifies struggling students (8,000).
